Lovers of fine arts and crafts will find a vast array of artisans and crafters displaying and selling their unique creations in pottery, sculpture, glass, jewelry, fashion, home décor, furniture and home accessories, items for the garden, and photography. The Festival will also introduce new and emerging artists showcasing the latest trends in handmade fashion and accessories, jewelry and fine art. This annual event is located in the heart of Beautiful Downtown Crested Butte in the town parking lot on **Elk Avenue**. The show is happening on a <u>very busy weekend as it is the peak of the Autumn Fall colors and simultaneous and right next to the bustling Farmer's Market on Sunday.</u>

The ARTumn Festival is an annual event, located at 1st and Elk Avenue which is the main street in the center of downtown. Crested Butte is one of the most beautiful towns in Colorado and its population a very well educated and affluent. This historic town is one of the most beautiful places in the Rocky Mountains and has been rated as one of the last great ski towns in America. Kebler Pass road starts in Downtown Crested Butte and has the largest Aspen Grove in the world that is spectacular this time of year.



How to be an exhibitor:

This is an Art and Craft Festival so all work sold must be of original design and all items must be handmade. In order to participate, you will need to fill out an application. There are 2 ways to apply:

1. **Apply online** - This is the most popular way to apply and is what you should choose if you prefer to pay by credit card, debit card or PayPal. The online application found at the top menu of the website www.coloradoevents.net or www.artfestivalsincolorado.com

All online applications will be juried about 2 to 3 times a month on an ongoing basis. You should know the outcome of you application within 2 weeks of applying if not sooner. Online Applicants will be notified of their acceptance into the show via email. Upon acceptance you will also receive an invoice to pay the exhibitor fee with PayPal or any credit card of your choice.

2, **Apply through the mail** — Choose this option if you prefer to pay by check. The paper application is attached to this document. Please return the paper application to us via the mail. Please also include 2 checks <u>made payable to Colorado Events</u> and be send it to: Colorado Events 2525 Arapahoe Ave, Suite E4-720, Boulder, CO 80302 If you choose to sign up with a paper application you have the option to mail us photos of you work. All paper applications should include two checks: a \$20 (Single Event) or \$25 (Multiple Event) non-refundable application fee and a separate check for the appropriate vendor fee. Email notices will be given out shortly thereafter. If you want to speed up the jurying process, you should apply online. We will notify all applicants of their acceptance decision via email. If you are accepted into the show then we will email you and also cash your 2nd check for the vendor fee. If you are not accepted we will shred the 2nd check. You can optionally include a postage paid, pre addressed envelope if you prefer to have the 2nd check returned to you or if you want us to return the jury photos that you sent us.

Jurying

You can choose from either a one-time \$20 jury fee for this one event or you can choose a multiple event jury fee of \$25. If you choose the multiple jury fee option, then you can apply to as many juried events that Colorado Events produces in 2024 for one low jury fee. The cost to apply is the \$20 or \$25 jury application fee. The 2 day vendor fee is due 30 days from the date of being notified of acceptance into the show. Should your acceptance date fall within 30 days or less of the event dates, then you will be expected to pay the vendor fee within 7 days of notification of acceptance.

A jury entry will be judged for eligibility based upon quality, originality and presentation. We are looking for distinctive high quality craftsmanship and unique art and crafts. Our curation process will ensure an appropriate balance for the entire show, when determining the number of artists invited for each medium.

Additional Information

Categories of products and services will be limited. This will permit the products being sold to be diverse and non-competitive. Certain categories may be sold out even if there are other spaces available. All sellers are subject to approval. Colorado Events reserves the right to restrict the sale of certain items and we reserve the right to refuse anyone from selling at these events. We also reserve the right to deny booth sharing in certain situations. If you do share a booth, neither vendor is permitted to sell jewelry.

Booths spaces are assigned by Colorado Events. If you want to guarantee a specific booth location request, then you should select the pick your booth location option on the application. If you choose this option you will be given the opportunity to pick your booth location out of all of the available spaces.

You can either bring your own supplies or you can rent chairs, tents, and tables from us. Colorado Events will be renting a limited number of tents, done on a first come, first serve basis. Please be prepared for Colorado's variable weather conditions by using weights for your tents and having tarps or sidewalls to protect your merchandise if necessary. Exhibitors must provide weights to secure tents to flat paved area. You will also be required to completely clean your selling space at the end of the day. There is no electricity available at this event.

Taxes:

All sales will be transacted directly between the artist and the buyer and all exhibitors must collect sales tax on all purchases. All vendors will be required to turn in their collected Town sale taxes at the end of the event. More details regarding sales tax will be provided in the vendor instructions.



In order to sell at the **2024 Crested Butte ARTumn Festival**, you will be required to fill out either our online application or this application. Paper applications should include a check and be sent via the mail. If you want to pay with a credit card or Paypal then you need to fill out our online application. This application does not guarantee acceptance, you will be notified shortly after your application is juried.
